Overview

Assembly Bill No. 1204 requires the Department of Health Care Access and Information (HCAI) to develop and administer a Hospital Equity Measures Reporting Program to collect and post summaries of key hospital performance and patient outcome data regarding sociodemographic information, including but not limited to age, sex, race/ethnicity, payor type, language, disability status, and sexual orientation and gender identity.

Hospitals (general acute, children's, and acute psychiatric) and hospital systems are required to annually submit their reports to HCAI. These reports contain summaries of each measure, the top 10 disparities, and the equity plans to address the identified disparities. HCAI is required to maintain a link on the HCAI website that provides access to the content of hospital equity measures reports and equity plans to the public. All submitted hospitals are required to post their reports on their websites, as well.

Patient Received Information in Writing

We are committed to ensuring health equity for all by addressing the underlying causes of racial and economic inequities and health disparities. Our Vision is "Health for a Better World," and to achieve that we believe we must address not only the clinical care factors that determine a person's length and quality of life, but also the social and economic factors, the physical environment, and the health behaviors that all play an active role in determining health outcomes. Our approach to health equity is both systemic and patient centered. We embed equity into every aspect of care delivery by integrating language access, behavioral health services, and social determinants of health screening into standardized workflows. We recognize that disparities in health outcomes often stem from barriers such as poverty, housing instability, food insecurity, and limited access to culturally competent care. To address these challenges, we partner with community organizations, faith-based groups, and local agencies to connect patients to essential resources beyond the hospital walls. Measurement and accountability are central to our equity strategy. We stratify key performance indicators-such as

readmission rates, access to interpreter services, and completion of social needs screenings-by demographic factors to identify gaps and implement targeted interventions. Through continuous improvement cycles, we work to close these gaps and ensure that every patient receives care that is equitable, respectful, and responsive to their unique needs. Health equity is not a standalone initiative; it is woven into our mission and values. By addressing systemic inequities and fostering partnerships that extend care into the community, Providence strives to create a future where every person has the opportunity to achieve optimal health, regardless of race, income, or social circumstance. #1 & #4: Goal: Include/consider maternal age in 100% of NTSV cesarean section cases reviewed. Performance in the priority area

General acute care hospitals are required to provide hospital equity plans that address the top 10 disparities by identifying population impact and providing measurable objectives and specific timeframes. For each disparity, hospital equity plans will address performance across priority areas: person-centered care, patient safety, addressing patient social drivers of health, effective treatment, care coordination, and access to care.

Person-centered care

At Santa Rosa Memorial Hospital, we share the Providence mission: "As expressions of God's healing love, witnessed through the ministry of Jesus, we are steadfast in serving all, especially those who are poor and vulnerable." Our core values-compassion, dignity, justice, excellence, and integrity-are the foundation of everything we do. These values are not just words; they are lived through our policies, communications, and daily actions. From the moment an applicant expresses interest in joining our team, through onboarding and throughout their career, these principles guide how we interact with patients, families, and each other. Person-centered care means recognizing that every patient's health journey is unique. We place the patient at the center of all decisions and ensure care is tailored to their needs, preferences, and cultural background. Interpreter services are available through phone and video platforms, allowing patients to communicate in their preferred language without barriers. All patient education materials come in multiple languages and are translated by certified medical interpreters to ensure accuracy and cultural appropriateness. Consent forms are written in clear, understandable language so patients never agree to a procedure without fully understanding its purpose. Beyond communication, we provide programs that support patients during and after hospitalization. Our Care Network program bridges the gap between hospital and home, focusing on culturally competent care and addressing health disparities. We also offer home health services, case management, and community health workers to assist with discharge planning, medication access, and follow-up appointments. These resources are especially critical for Hispanic/Latinx and rural populations, who experience higher rates of chronic illness and limited access to care. By addressing social determinants of health and removing barriers, we help patients heal in environments that support their well-being. Measurement and Accountability: We monitor interpreter utilization rates, HCAHPS scores, and social determinants of health screenings, and we follow up on positive screens to ensure continuity of care. Patient feedback is gathered through Press Ganey surveys, and we are exploring patient advisory councils to guide improvements. These efforts reflect our promise: "Know me, care for me, ease my way." Through collaboration, cultural sensitivity, and innovation, Santa Rosa Memorial Hospital strives to deliver care that honors the dignity and uniqueness of every person.

Patient safety

Patient safety at Providence Santa Rosa Memorial Hospital is the foundation of all clinical care. We employ evidence-based protocols, rigorous audits, and standardized checklists to minimize risk and prevent harm. Our initiatives-such as early identification of high-risk patients, timely completion of assessments, and enhanced discharge education-are designed to ensure safe transitions across care settings. We are actively working toward becoming a High Reliability Organization (HRO), embedding reliability principles into every aspect of care delivery. This means maintaining a constant preoccupation with failure, resisting oversimplification of complex issues, and fostering sensitivity to operations. We emphasize resilience and rapid recovery from unexpected events and defer to expertise by empowering staff at all levels to speak up and act on safety concerns. Our robust reporting system, grounded in a Just Culture, encourages staff to report errors and near misses without fear of punitive action. This transparency fosters learning and continuous improvement, ensuring that safety is not only a priority but a shared responsibility across the organization. AB 1204 reinforces the importance of safety through its mandate to reduce disparities and improve outcomes. By embedding equity-focused interventions into our workflows and monitoring compliance through stratified data, we address systemic risks that disproportionately affect vulnerable populations. Continuous improvement cycles, informed by real-time data and multidisciplinary reviews, allow us to identify gaps and implement corrective actions promptly. Patient safety is not limited to clinical procedures; it encompasses communication, coordination, and education. Through proactive planning and collaboration, we create a care environment where every patient receives safe, reliable, and equitable treatment.

Addressing patient social drivers of health

Our organization recognizes that health outcomes are influenced by more than clinical care alone. Social Determinants (SDOH) of Health such as housing stability, food security, transportation access, education, and economic opportunity play a critical role in shaping patient well-being. Addressing these factors is essential to achieving health equity and improving overall quality of care. We systematically identify and address social needs that impact health outcomes. To achieve this, we screen all patients for key social drivers, including housing, food, transportation, and financial insecurity, and stratify findings by race, ethnicity, language, and other demographics to uncover disparities. We partner with community-based organizations to connect patients to resources and provide culturally and linguistically appropriate support. We use FindHelp an electronic medical record search tool that assists caregivers in finding community-based social services that address social drivers of health. FindHelp can generate a comprehensive list of local resources patients need to maintain their health and well-being. Additionally, we integrate SDOH data into care planning and population health strategies to ensure interventions are equitable and responsive to the unique needs of our diverse patient population.

Performance across all of the following priority areas.

Effective treatment

Effective treatment at Providence Santa Rosa Memorial Hospital is rooted in evidence-based practices and tailored to individual patient needs. Our targeted action plans demonstrate how best practices are translated into measurable improvements that strengthen transitions of care, enhance patient education, and address barriers to recovery. These initiatives ensure treatment plans are comprehensive, equitable, and sustainable beyond hospitalization. We are committed to continuously evolving and enhancing all measures submitted to CMS and The Joint Commission. This includes refining workflows, improving documentation accuracy, and leveraging real-time data to identify gaps and implement corrective actions. Our teams actively review performance on core measures, patient safety indicators, and readmission metrics to ensure compliance and drive improvement. This work is supported by multidisciplinary collaboration and the integration of best practices from national benchmarks and evidence-based guidelines into daily workflows. Our commitment aligns with national quality standards and regulatory expectations, including those set by leading accrediting and performance organizations. By embedding these strategies into standardized workflows and leveraging data-such as readmission reviews and related analyses-we ensure compliance while advancing quality goals. Continuous monitoring of outcomes, coupled with structured audits and feedback loops, drives improvement across clinical processes and patient experience. This approach directly supports HCAI AB 1204 requirements by identifying disparities. implementing targeted interventions, and tracking measurable progress through stratified data. Our work reflects the law's emphasis on equity, transparency, and continuous improvement, ensuring that care delivery meets both regulatory standards and community needs. Ultimately, effective treatment is more than meeting benchmarks-it is about delivering safe, equitable, and personcentered care. Through collaboration, education, and proactive discharge planning, we empower patients to manage their health beyond hospitalization, reducing readmissions and improving longterm outcomes.

Care coordination

Care coordination is especially important for those patients with complex medical and social drivers of health needs. Providence NorCal provides a robust continuum weaving inpatient care management to our community based complex care management program, CARE Network. CARE Network is a mission driven no cost program serving highly vulnerable individuals through intensive, community-based medical and psychosocial care management. Services are provided to community residents with complex health, behavioral, and social challenges, including the following: Homelessness and housing stability, one or multiple chronic conditions, lacking basic needs mental health challenges, substance use disorders, inadequate financial resources, limited social supports, language/health literacy barriers. Inpatients are screened and those with complex needs are referred to CARE Network upon discharge. CARE Network provides telephonic and in person home visits to support patients with medication management, follow up medical appointments, transportation, in addition to food and other SDoH. We work closely with our FQHCs and other community-based organizations to link patients to services. Behavioral health needs are supported through collaboration with a psychiatric liaison and substance use navigator, and behavioral health follow-up scheduling is embedded in discharge planning. Social determinants of health are documented in Epic and visible to CARE Network teams when referrals are placed. Digital tools such as MyChart and text reminders help patients stay engaged in their care. We work closely with our community-based organizations to link patients to services. On the acute side, the readmission committee meets weekly to review cases and the fourth week of each month to plan improvements. Metrics such as CARE Network enrollment rates, reduced ED visits, and improved medication

adherence are tracked, and stratified data is used to monitor equity, though prioritization for multiple SDOH needs and telehealth expansion remain opportunities for development. Through these efforts, Providence NorCal ensures that care coordination is comprehensive, culturally responsive, and focused on reducing barriers for the most vulnerable populations.

Access to care

In the tradition of our Catholic heritage, we serve all, with special attention to the poor and vulnerable. One way Providence supports access to care for all is through our financial assistance program. We inform the public of this program by posting notices in high volume inpatient and outpatient service areas and at locations where a patient may pay their bill. Notices include contact information on how a patient can obtain more information on financial assistance as well as where to apply for assistance. These notices are posted in English and Spanish and any other languages that are representative of 5% or greater of patients in the hospital's service area. All patients who demonstrate lack of financial coverage by third party insurers are offered an opportunity to complete the Patient Financial Assistance Application and are offered information, assistance, and referral as appropriate to government sponsored programs for which they may be eligible. Beyond financial assistance, we provide robust community benefit contributions that deliver direct services such as CARE Network, mobile dental units in Napa and Sonoma, mobile health clinics in Sonoma, free community health screenings, and community resource centers in Humboldt. These services focus on underserved, vulnerable populations and provide clinical care and navigation services to ensure access to care. We also leverage services to reach rural and transportation-limited populations. expanding access to specialty care and follow-up visits. Our commitment to access is reinforced by EMTALA compliance and charity care policies, ensuring that emergency care is provided regardless of ability to pay. Through community partnerships, referrals, and outreach, we strive to remove barriers and connect patients to the care they need. These efforts reflect our mission and values, ensuring that every person, especially those who are poor and vulnerable, has equitable access to health services.
