

Sounders FC Providence Pledge Sweepstakes Terms and Conditions

Official Rules of Sounders FC Sweepstakes

The Sounders FC Providence Pledge Sweepstakes (the “Sweepstakes”) is sponsored by Seattle Soccer, LLC d/b/a Seattle Sounders FC and Providence Health & Services – Washington, including its current and future subsidiaries and affiliates (“Sponsor”). **No purchase necessary. A purchase will not increase your chances of winning.** To enter, you must meet the eligibility requirements and participate in accordance with the rules set forth herein. The Sweepstakes is void where prohibited or restricted by applicable law, and all applicable federal, state, and local laws and regulations apply. Winners are responsible for any taxes, customs, duties and like amounts with respect to any Sweepstakes prizes. The Sponsor reserves the right to cancel, modify or suspend the Sweepstakes at any time.

6. ELIGIBILITY.

Eligibility to participate in the Sweepstakes or to win prizes is limited to persons who are legal residents of the State of Washington, excluding the city of Vancouver, whom are at least eighteen (18) years of age or older on the date of entry. The Sweepstakes is void where prohibited or restricted by law, regulation, rule, or otherwise. Submissions will be considered ineligible if they contain obscene, derogatory, and/or offensive language. Any effort by an entrant to misrepresent their eligibility will disqualify that entrant. Entrants who disregard these Official Rules are not eligible to participate or win any Sweepstakes prizes. Directors, officers, employees, contractors, agents and licenses, or their immediate families and household members (spouse, parent, child and sibling and their respective spouses, regardless of where they reside) of Sponsor, Major League Soccer, L.L.C. (“MLS”), and Soccer United Marketing, LLC (“SUM” and collectively with Seattle Sounders FC and MLS, the “MLS Entities”) and each of their parents, affiliates, subsidiaries, and advertising and promotion agencies are not eligible.

2. NO PURCHASE NECESSARY. HOW TO PLAY.

The Sweepstakes will begin at 10:00 AM PT on May 17, 2023, and conclude at 11:59 PM PT on October 4, 2023 (“Sweepstakes Entry Period”). There are two (2) methods of entry. Only one (1) entry per person. If more than one (1) entry is received from any entrant only the first entry will be included, and all subsequent entries shall be disqualified as ineligible. By submitting an entry, entrant agrees to be bound by these Official Rules and understands that the decisions of Sponsor, at its discretion, are binding and final. Further, the entrant waives any right to claim harm, misconduct, or ambiguity with regard to the Sweepstakes or these Official Rules.

A. Methods of Entry

SoundersFC.com: Entrant can complete the “enter to win” form located on SoundersFC.com to enter to win. The content gathered can and will be used for diagnostic, promotional, and marketing purposes. Entrant grants Sponsor use of their name, image, likeness, and all content that may be produced in association with entering the Sweepstakes. Entrants must fully complete and submit all non-optional data requested on the online entry form to be eligible.

Alternative Means: Entrant can also handprint their name, address (including zip code), age, email address and day and evening phone numbers, with area codes on a piece of paper and

send the form labeled Sounders FC Providence Pledge Sweepstakes to Seattle Sounders FC, 406 Occidental Ave., S, Seattle, WA 98104. The content gathered from the form can and will be used for diagnostic, promotional, and marketing purposes. Entrant grants Sponsor use of their name, image, likeness, and all content that may be produced in association with the Sweepstakes.

Incomplete entries are void. Online entrants to the Sweepstakes will be given the option to receive commercial e-mails from MLS Entities; however, eligibility to participate in the Sweepstakes is not contingent upon entrant's consent to receive such e-mails and consenting to do so will have no effect on an entrant's chances of winning.

3. PRIZES.

There will be twenty (20) prizes in total awarded throughout the Sweepstakes. The prizes include: Ten (10) Sounders FC Autographed Jerseys, and Ten Sets of two (2) tickets. In consideration of accepting a prize, prize winners will assume sole responsibility for all costs associated with any component of the prize not addressed within the Official Rules, including without limitation, all federal, state, and local taxes incurred as a result of claiming a prize. Sponsor will furnish proof of value received or other documentation if requested by prize Winner. The prize is not transferrable and may not be substituted for cash or cash equivalent. **Approximate Retail Value of the Sounders FC Jersey is \$159.99. Approximate retail value of the two (2) tickets is \$150.00. Autographs have no Approximate Retail Value.**

4. DRAWING.

5. PRIZE CLAIM.

Prizes must be claimed by winner by responding to Sponsor's email notification prior to 11:59 PM PT on October 7, 2023. If any prize winner cannot be reached and/or does not respond to the email prior to 11:59 PM PT on October 7, 2023, is found to be ineligible, or otherwise fails to follow any terms or conditions in these Official Rules, the Sponsor maintains the authority to disqualify the prize winner or otherwise consider the prize as forfeited, at Sponsor's discretion, and another prize winner may be selected. Any winner notification sent by email which is returned as undeliverable will result in disqualification and an alternate winner will be selected.

Claimed prizes will be awarded. A disqualification will result in the Prize being forfeited and, at Sponsor's sole discretion and time permitting, an alternate Winner may be selected from among all remaining eligible entries if all such required information and documents are not properly executed and returned within the specified period. Refusal or return of such documents as non-deliverable or Winner's noncompliance with these Official Rules will also result in disqualification and forfeiture of a Prize and, at Sponsor's sole discretion and time permitting, may result in an alternate Winner being selected from among all remaining eligible entries.

Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by website users, tampering, hacking, or by any equipment or programming associated with or utilized in the Sweepstakes.
