WAADAA KEENYA DHUKKUBSATAa KEENYA, ISINIIF:

Providence St. Joseph Health and its affiliates, keessatti fayyaan mirga dhala namaati jennee amanna. Namni kamiyyuu jireenya isaa isa fayya qabeessa ta'e jiraachuun isaaf mala. Ergamni keenya kabajaa fi garaagarummaa nama tokkoon tokkoo kabajuudhaan hunda akka kunuunsinu nu gaafata. Sadarkaa jireenyaa kamiyyuu irratti isin simanna, kunuunsa akka nama guutuutti isin beekuu fii isin mirkaneessu kennuudhaaf waadaa seennee jirra. Yeroo jireenyaa hunda caalaa qulqulluu ta'e akka kabajjaniif akkasumas yeroo ulfaataatti akka isin cinaa dhaabbannuuf haala simannaa, nageenyaafi kabaja qabu uumuuf carraaqna. Akka isin dhageenyuu, akka isin hubannuu fi galma fayyaa keessanii galmaan ga'uuf isin waliin hojjechuuf nutti amanuu dandeessu. Bakka fayyinaa fi fayyaa caalaa, walcaalmaa fayyaa dhabamsiisuuf waadaa seennee jirra, kunis hundaaf kunuunsa nageenya qabu, qulqullina olaanaa qabu, bu'a qabeessa ta'e haqaan akka argatu gochuu dabalatee. Loogii hin goonu, kunuunsa loogii irraa bilisa ta'e abdachuu dandeessu. Kunuunsa keessan imaanaa nutti kennuu keessaniif isin galateeffanna– innis itti gaafatamummaa fi kabaja keenya isa guddaadha.

AKKA DHUKKUBSATAA KEENYAATTI,
MIRGOOTA KANNEEN QABDU:

Kabajuu, ulfinaa, fi haqaa

Kunuunsa namaaf yaaduu, gara laafinaa, iccitii fi kabajaa argachuuf mirga qabdu. Ulfinaan ni qabamtu, kanaaf tuffii, gowomfamuu, miidhaa, rakkina, sanyummaa yookiin loogii irraa bilisa ni taatu. Dhukkubsattoonni hundi miidhaa qaamaa yookiin sammu, fi adabbii qaamaa irraa bilisa ta'uuf mirga qabu. Providence St. Joseph Health and its affiliates, namoota nu daawwatan hundaaf kunuunsa qulqullina olaanaa qabu, hunda hammate ni kenna. Akka nama addaa taatanitti isin ilaalla, kunuunsa keessan haala aadaa wajjin walsimuun ni kennina.

Sababoota cunqursaa maqsuuf kutannee jirra. Namoota dhuunfaa tajaajila argatan hunda ni kabajna, ulfinaan kunuunsina. Namoota sanyii, umrii, amantii, gosa, aadaa, ka'umsa sabaa, lammummaa, afaanii fi/yookiin haala godaansaa, haala dinagdee, madda kaffaltii kunuunsaa, amantii, duudhaa, gocha, fi dhufaatii hundaa ni simannaa. Gaa'ela, walqunnamtii mana keessaa, ykn gamtaa siiviilii, bifa fi guddina qaamaa, saala, fedhii saalaa fi eenyummaa ykn ibsa saalaa hunda ni kabajna. Hir'ina qaamaa yookiinn hir'ina xiinsammuu yookiin bilchinaa, hir'ina qaamaa ykn dandeettii, haala fayyaa (haala HIV/AIDS, kaansarii, jeneetikii, itti fayyadama wantootaa fi rakkoo nyaataa dabalatee), seenaa yaalaa maatii, haala durii ykn waraanaa, fi

ka'umsa biyyaalessaa, umrii, qaama miidhamummaa (seera farra loogiitiin beekamtii argate), ykn saala (ulfa, fedhii saalaa, eenyummaa saalaa, fi ibsa dabalatee), fi gosoota biroo hunda seericha jalatti eegumsa argatan. Hojjettoonni hospitaalaa fi ogummaa qaban madaallii dhukkubsattoota amala dandeettii dhukkubsataan ofii fi namoota biroo miidhaa yookiin madaa'uu irraa eeguu dhorkuu danda'u agarsiisan irratti barnootaa fi leenjii (akkaataa ulaagaalee seeraa fi dambiitiin) ni argatu.

Daawwattoota keessan filataniif

Akkaataa imaammata hospitaalaa fi kilinikaa hojiirra jiruun daawwattoota filattan simachuuf mirga qabdu. Daawwattoonni kunniin, haadha warraa, hiriyyaa manaa (hiriyyaa manaa saala walfakkaataa qabu dabalatee), miseensa maatii kan biraa ykn hiriyyaa kan dabalatu yoo ta'u, garuu kanneen kanaan qofaan hin daangeffamne. Daawwattoonni kun sababa sanyii, halluu, madda sabaa, saala, fedhii saalaa, eenyummaa saalaa yookiin ibsa, umurii, yookiin qaama miidhamummaatiin mirga daawwannaa hin daangeffaman yookiin karaa biraatiin hin dhorkaman. Yeroo barbaaddetti waliigaltee akkasii ofirraa baasuu ykn dhorkuuf mirga qabdu.

Akkasumas miseensi maatii yookiin bakka bu'aa

amala seera federaalaa, yookiin naannootiin eegumsa argate kamiyyuu ni simannaa kunuunsa haqa qabeessa ni kennina.

Gara naannoo nageenya qabuutti

Bakka nageenya qabuutti kunuunsa argachuuf, tajaajila eegumsaa fi abukaatummaa argachuuf, akkasumas miidhaa fi doorsisa irraa bilisa ta'uuf mirga qabdu.

Qoodamuu yookiin kophaa ta'uu irraa bilisa ta'uuf

Qoodamuu yookiin kophaa ta'uu irraa bilisa ta'uuf mirga qabda. Sababoota armaan gadii irratti hundaa'uun qoodamuu yookiin kophaa ta'uun dhorkaadha: sanyii, halluu dhukkubsataa,

filannoo mataa keessanii fi hakiima kunuunsa jalqabaa mataa keessanii dhukkubsataa mana yaalaa keessaa hospitaala seenuu hatattamaan beeksisuuf mirga qabdu.

Kunuunsa yaalaa fedhii addaa keessaniif deebii kennu argachuuf

Tajaajila, wal'aansa ykn bakka boqonnaa dhaabbilee keenya keessatti argamaniifi yaala fayyaatiin barbaachisoo ta'an argachuuf mirga qabdu. Galmi keenya galma fayyaa fi jireenyaa dhuunfaa keessanii wajjin walsimsiisuu fi eenyummaa keessan hunda tilmaama keessa galchuudha. Akkaataa imaammata hospitaalaa hojiirra jiruun, dhukkubsattoonni qaama miidhamtoonni yoo xiqqaate nama deeggarsaa tokko yeroo hunda kutaa balaa tasaa fi/ykn yeroo turtii hospitaalaa keessatti akka argamu dabalatee yoo xiqqaate namoota deeggarsaa sadii muuduuf mirga qabu.

Murtii kunuunsa fayyaa keessan irratti mari'achuu fi hirmaachuuf

Kunuunsa keessan ilaalchisee mari'achuu, gaaffii gaafachuu fi murtoo murteessuuf mirga qabdu. Isin caalaatti of beektu, kanaafidha galma fayyaa keessanii dhaggeeffannee galmaan ga'uuf isin waliin kan tumsinu. Waa'ee wal'aansaa yeroo murteessitan duudhaawwan dhuunfaa, aadaa fi afuuraa, filannoo fi amantaa keessanii ni qabaattu. Yoo barbaaddan, murteessaan amanamaan keessan yookiin namoonni biroo isin filattan murtoo waa'ee kunuunsa keessanii irratti hirmaachuu danda'u. Akkasumas gorsa ogeessaa, ogeessa naamusaa fi/yookiin lubaa gaafachuuf mirga qabdu. Akkasumas, kunuunsa kennamu yookiin kennamuuf yaadame akka hubattan mirkaneessuuf akka gargaaruuf, tajaajilli afaan hiikaa baasii tokko malee isiniif ni jiraata.

Hawwiin keessan akka kabajamuuf

Murtoon wal'aansa keessanii akka kabajamu mirga qabda. Waa'ee kunuunsa keessanii murtii kennuu keessatti ofuma keessanii dubbachuu yoo dadhabdan, murtii nama ati akka aangoo abbaa seerummaa keessanii kunuunsa fayyaa, bakka bu'aa kunuunsa fayyaa, yookiin murteessaa amanamaa ta'etti moggaastan ni kabajna. Qajeelfamni dursaa yookiin sanadni karoora kunuunsa dursaa kan biraan wal'aansa addaa ilaalchisee filannoo yoo agarsiise, daangaa haala keessaniin kaa'ame keessatti filannoowwan keessan ni kabajna. Yoo qajeelfama dursaa yookiin sanada karoora kunuunsa dursaa walfakkaatu galmee irratti hin qabne ta'e, tokko guutuuf akka si gargaarru ni dhiheessina. Xiyyeeffannaan kunuunsa hanga dhuma jireenyaatti Providence fedhii dhukkubsattootaa fi namoota jaallatan guutuu, gidiraa isaanii salphisuu fi qulqullina jireenya isaanii fooyyessuudha. Kunuunsa itti fufiinsa guutuu ta'een kunuunsa hafuuraa, kunuunsa tasgabpii fi kunuunsa hospisii argachuuf carraa ni kennina. Yeroo barbaachisaa ta'etti, akka qajeelfama keessaniitti arjooma qaamolee fi tishuuwwan biroo qindeessuuf ni gargaarra, kunuunsa dhuma jireenyaa gara laafina qabu ni kennina.

Waliigaltee beeksisuu fi kunuunsa diduu

Kunuunsa keessan ilaalchisee murtoo sirrii ta'e murteessuu akka dandeessaniif, qorannoo keessan, wal'aansaa fi raajii keessan haala isin hubattaniin hakiima keessan beeksisuudhaaf mirga qabdu.

Kunis mirga wal'aansa diduu yookiin hospitaala gadhiisuu kan dabalatu yoo ta'ellee, sababa dhiyeessaan fayyaa keessan akkas akka hin goone yoo gorfamellee.

Itti fufiinsa kunuunsaaf

Fedhii kunuunsa fayyaa itti fufiinsa qabu kan yeroo kunuunsa fi dhaabbilee keenya keessaa baatan jiraachuu danda'u karoorsuu keessatti yeroo isin gargaarru filannoowwan qabdan hubachuuf odeeffannoo isin dandeessisu argachuuf mirga qabdu. Kunis wal'aansa qindeessuun, madaallii fi yoo barbaachisaa ta'e gara dhaabbata biraatti jijjiiruu dabalata.

To'annoo dhukkubbii gahaaf

Kunuunsa fi tajaajila osoo argattanii dhukkubbiin keessan akka to'atamu mirga qabdu.

Waa'ee kunuunsa keessanii waliin haasa'uuf

Wal'aansa argachaa jirtan akka barattanii fi gaaffii akka gaafattan ni jajjabeeffamtu. Yoo barbaachisaa ta'e hojjettoonni keenya baasii tokko malee afaan hiikaa isinii kennu yookiin kunuunsa isiniif kennamaa jiru yookiin yaada dhihaate guutummaatti akka hubattaniif mala biroo ni kennu. Yoo akka hin goone nutti himtan malee, ogeessa kunuunsa jalqabaa hundeeffame, garee/qaama hojii kunuunsa jalqabaa, ykn garee/qaama ogeessa fayyaa biroo, akkasumas kennitoota tajaajila kunuunsa cimaa boodaa fi dhiyeessitoota hojiirra oolan hundaaf galmee keessan beeksisuuf, gadhiifamuu, ykn hospitaala irraa jijjiirraa keeraan beeksisuuf mirga qabna. Gaaffii keessan irratti hundaa'uun, hospitaala keenya irraa seenuu, gadhiifamuu ykn jijjiirraa keessan filannoo keessan miseensa maatii ni beeksifna.

Galmeewwan fayyaa keessaniif

Waa'ee haala fayyaa keessanii, qorannoo, raajii, adeemsa wal'aansaa, abdi fayyuu fi bu'aa kunuunsa jechoota hubachuu dandeessaniin odeeffannoo argachuuf mirga qabdu. Galmee fayyaa keessanii argachuuf mirga qabdu. Beeksisa Gochaalee Dhuunfaa adda ta'ee fi mirga galmee keessan argachuuf qabdan ibsu ni argattu. Walqunnamtii bu'a qabeessa ta'e qabaachuu fi karoora kunuunsa keessan qopheessuu fi hojiirra oolchuu irratti hirmaachuuf mirga qabdu.

Hanga danda'ametti, kun ibsa haala keessanii fi hojimaata fi yaala yaadame hunda irratti hundaa'uu qaba, kunis balaa cimaa ykn miidhaa cinaa kamiyyuu, rakkoowwan fayyina waliin walqabataniifi carraa milkaa'ina dabalatee. Kana malees, hojimaataa fi yaala yaadame qabaachuu dhabuun balaa fi faayidaa isaa hubachuuf mirga qabdu. Mirgi wal'aansa argachuu keessanii qajeelfama qabaachuu fi ol'aanaa, POLST, yookiin ajaja deeggarsa jireenyaa ofirraa baasuu yookiin dhorkuu kan akka ajaja Do Not Resuscitate irratti kan hundaa'e miti. Dhukkubsattoonni fi namoonni muudaman, hanga danda'ametti, pirojektoota qorannoo yookiin dhimmoota naamusaa uumamuu danda'an kamiyyuu dabalatee, murtii kunuunsa yaalaa isaanii ilaalchisee kennamu irratti hirmaachuuf mirga qabu.

Dhuunfummaa fi iccitiidhaaf

Qunnamtii fi galmee kunuunsaa fi turtii keessan ilaallatu hunda iccitiidhaan yaalamuuf mirga qabdu. Beeksisa Shaakalawwan

Dhuunfaa adda ta'e kan mirga icciti keessanii bal'inaan ibsu fi akkaataa odeeffannoo yaalaa keessan itti fayyadamuu fi ibsuu dandeenyu ni argattu. Iccitiin dhuunfaa keessan akka kabajamu mirga qabdu. Mariin dhimmaa, gorsi, qorannoon fi wal'aansi icciti waan ta'eef of eeggannoodhaan gaggeeffamuu qaba. Maqaa ogeessa eegumsa fayyaa hayyama qabuu fi daangaa hayyama ogummaa isaa keessatti hojjetu kan kunuunsa qindeessuuf itti gaafatamummaa jalqabaa qabu, maqaa fi hariiroo ogummaa hakiimotaa fi ogeeyyii fayyaa hin taane dhukkubsataa arguu fi itti himamuu sababa namni dhuunfaa kamiyyuu achitti argamuu isaanii beekuuf mirga qabdu.

Waa'ee kunuunsa keessanii komii sagalee dhageessisuu fi deebii nu irraa argachuuf

Qulqullina yookiin kenniinsa kunuunsa keessanii irratti dhiibbaa osoo hin geessisin, waa'ee kunuunsa keessanii yaaddoo yookiin komii dhageessisuu fi deebii nu irraa argachuuf mirga qabdu.

Dhimmoota waldhabdee furuu, tajaajila lubbuu namaa deebisuu dhorkuu fi wal'aansa lubbuu namaa itti fufsiisu dhiisuu ykn ofirraa baasuu dabalatee gaaffiiwwan naamusaa yeroo kunuunsa keessanii ka'an irratti hirmaachuuf mirga qabdu. Dabalataanis, poortala dhukkubsataa MyChart irratti galmaa'uuf mirga qabdu. MyChart odeeffannoo wayitawaa beellama, qoricha, haala fayyaa, mana yaalaa, qorannoo, gudunfaa daawwannaa boodaa, yaadannoo kilinikaa fi odeeffannoo biroo yeroo qabatamaa keessatti gaaffii qaqqabummaa addaa tokko malee ni kenna. Odeeffannoo dabalataaf maaloo Providence.orgdaawwadhaa.

Dhaabbilee hoggansaa armaan gaditti tarreeffaman kamiyyuu tti gabaasuu yookiin qunnamuu dandeessu. Odeeffannoon quunnamtii dabalataa komii gabaasuuf

dhaabbata kunuunsa fayyaa yookiin bakka filattanitti argama.

Itti gaafatamummaa faayinaansii keessanii fi filannoowwan gargaarsaa hubachuuf

Akka dhukkubsataa keenyaatti tilmaama baasii gaafachuu kan dandeessan yoo ta'u, waraabbii herrega ifa ta'ee fi hubatamaa ta'e kan meeshaalee adda addaatiin qophaa'e argachuuf mirga qabdu. Gaaffii yoo dhiyeessan himannaan akka ibsamu gochuus ni dandeessu. Yoo rakkoon maallaqaa isin mudate, maaloo wiirtuu tajaajila maamiltootaa keenya 1-866-747-2455 irratti qunnamaa. Waa'ee filannoo kaffaltii yookiin gargaarsa maallaqaa argachuuf ulaagaa guutuu fi dhiisuu keessan, uwwisa inshuraansni naalis ta'u maal baruu dandeessa. Dhukkubsattoota keenya kamiyyuu kaffaltii yaalaa kaffaluuf gargaarsa gaafatan waliin hojjechuuf waadaa seennee jirra.

Odeeffannoo imaammata dhaabbata kunuunsaa irratti

Yoo gaafatame, waa'ee imaammata, seera ykn dambiiwwan keenya kunuunsa keessan irratti raawwatiinsa qaban, bineensota tajaajilaa iddoowwan uummataa dhaabbilee kunuunsaa keessatti fayyadamuu dabalatee, seera federaalaa irratti hundaa'uun odeeffannoo ni argattu.

AKKA DHUKKUBSATAA, MISEENSA MATII, YOOKIIN DAAWWATAA ATI ITTI GAAFATAMUMMAA QABDU:

Providence St. Joseph Health and its affiliates, bakka fayyinaa yoo ta’u, kunuunsitoonni, dhukkubsattoonni, miseensonni maatii fi daawwattoonni walqixa simannaa, nageenyi fi kabaja itti isaanitti dhaga’amudha. Namoonni balbala keenyaan dhufan yookiin kunuunsa nu biraa barbaadan hundinuu haala ulfina nama hundaa kabajuun, kunuunsa qulqullina olaanaa qabu, garaa laafina qabu akka kenninu nu gargaaru akka qabaatan ni gaafanna, ni eeganna. Hojjettoonni keenya ogummaa fi muuxannoo isaaniitiin kan filataman yoo ta’u nageenyi isaaniis hunda caalaa barbaachisaadha. Rakkinni yookiin qabinsi seeraan alaa hojjettoota keenya irratti raawwatamu hin obsamu. Kunuunsa keenya keessa osoo jirruu yookiin nama jiru daawwannu, kanneen armaan gadii isin irraa eegna:

- Namoota kunuunsa godhan yookiin kunuunsa argatan dabalatee namoota naannoo keessan jiraniif yaadiif fi kabajas qabaadhuuf.
- Kunuunsitoonni sababoota gahee ogummaa isaanii wajjin wal hin qabanneef irra deebiin akka hin ramadamne hubadhaa.
- Afaan yookiin amala loogii fi/yookiin xiqqeessuu yookiin amala gosa kamiyyuu fayyadamuu irraa of qusadhaa. Hin obsamu, bu’aan isaas dhaabbaticha keessaa akka baafamtan yookiin akka ari’amtan gochuu danda’a.
- Waa’ee duraaduura fayyaa keessanii dhiyeessaa keessan beeksisaa, kanaaf karoora waliin baasuu dandeessu.
- Seenaa yaalaa fi odeeffannoo wal’aansaa keessan sirritti fi guutummaatti kennaa.
- Haala keessan irratti Jijjiirama hin eegamne gabaasaa, murtoo irratti hirmaadaau, fi waa’ee kunuunsa keessanii dhiyeessitoota gaaffii gaafadhaa.
- Gorsa dhiyeessitoota keessanii ilaalaa karoora wal’aansaa gorfamu hordofaa. Kunis yoo beellama kabajuu yookiin qajeelfama yaalaa hordofuu dadhabdan dhiyeessitoota keessan beeksisuu dabalata.
- Koppii qajeelfama dursa yaalaa keessanii, fedhii jireenyaa fi/yookiin eenyummaa fi odeeffannoo quunnamtii murteessaa amanamaa ta’e kan isiniin mudame, yoo qabaattan nuuf kennaa.
- Qajeelfama dursa yaalaa yoo hin qabaanne guutuudhaaf kunuunsaa keessan waliin hojjedhaa.
- Itti gaafatamummaa faayinaansii fi filannoowwan deeggarsa faayinaansii keessan hubadhaa.
- Imaammata dhaabbata kunuunsaa hordofaa.
- Meeshaa dhuunfaa hunda manatti dhiisaa.

MIRGA DABALATAA NAANNOO OREGON:

Namni qaama miidhamummaa qabu tokko kunuunsa fayyaa argachuuf gara Providence dhufe, mirga armaan gadii qaba:

- Yoo xiqqaate namoota deeggarsaa sadii filachuun yoo hirina qaamaa, sammuu, amala, ykn hubannoo, gurri isaanii hin dhageenye, dhageettii dhabuu ykn gufuu walqunnamtii biroo, jaamummaa, otizimii ykn dhibee yaada namaa hadoochu qabaatan, yoo xiqqaate waaee kunuunsa isaanii akka walqunnamanii fi murtoo akka kennan gargaaran. Namni deeggarsa miseensa maatii/kan biraa guddaa, guddiftuu, gargaaraa kunuunsa dhuunfaa ykn hojjetaa kaffaltii kan qabu ykn kan hin kaffalamneef kan biraa dhukkubsataan filate tauu dandaa. Yoo xiqqaate namni deeggarsa tokko kutaa balaa tasaa dabalatee yeroo hunda hospitaala keessatti dhukkubsataa waliin siree cinaa tauu dandaa.
- Kunuunsa hospisii ilaalchisee marii kamiyyuu, qajeelfama sadarkaa olaanaa mallatteessuu, ykn murtoo walaansa jireenya itti fufsiisu dhaabuu jechuu dandau murteessuuf yoo dhukkubsataan haala biraatiin gaafate malee namni deeggarsa qaamaan argamu qabaachuu qaba. Providence kenniinsa walaansaa dhukkubsataa POLST, qajeelfama sadarkaa olaanaa, ykn ajaja deggersa jireenyaa ofirraa baasuu ykn dhorkuu, kan akka ajaja Duubatti hin Deebisin qabaachuu irratti haala hin kaau.
- Gaaffiin dhukkubsataan tokko siree isaanii cinaa namni deggersa akka argamuuf dhiheesse hospitaalichaan yoo daangeffame ykn yoo dhorkame, carraa konfiraansii kunuunsa deeggarsa gaafachuun dhorkamuu fi namni deeggarsa tokko akka argamu hayyamuu dandau kamiyyuu irratti mariachuuf akka argatan hatattamaan ni beeksifama. Konfiraansiin deeggarsa kun dafee ni beellama, garuu erga seenee booda ykn adeemsa yookiin opereshinii tokko dura saatii 24 booda miti.
- Beeksisni kun gaaffii dhukkubsataa yookiin bakka buaa seeraa dhukkubsataa yoo tae bifa biraatiin ni argama.
